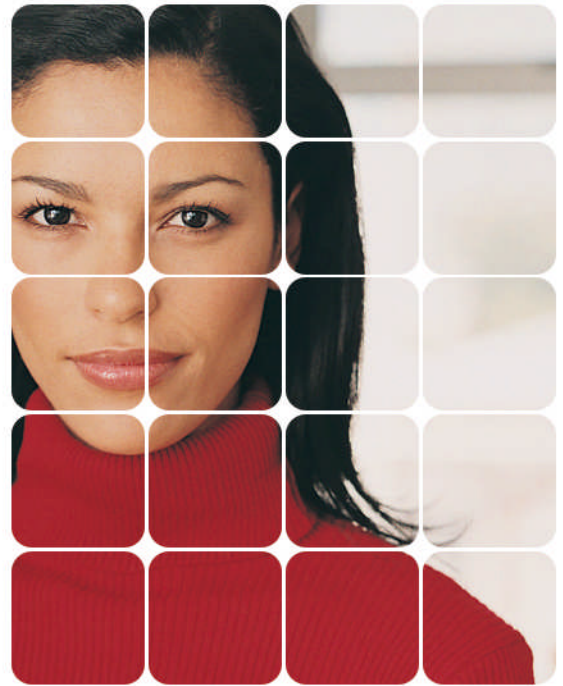

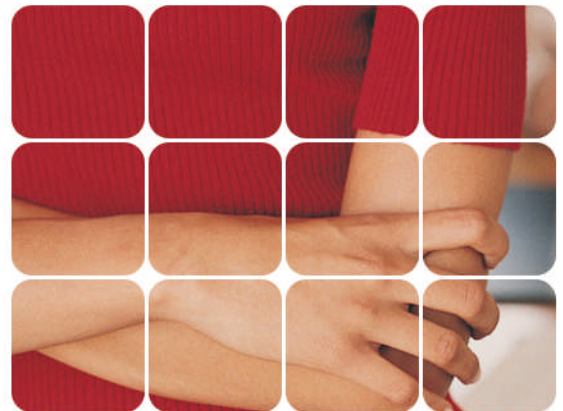

## Supporting Investors in People

Investors in People (IiP) Standard is a framework that help organisations to improve performance and realise business objectives through the effective management and development of their people.

An organisation can use the IiP standard to build key structures, processes, policies, and practices on effective management and development of its staff and managers so that the organisation can realise and improve business performance.

Alternatively, an organisation can seek to achieve the IiP accreditation by testing, through an assessment, its structures, processes, policies, and practices against the IiP standard indicators.

When the organisation achieves IiP recognition, it would be expected to produce an Action Plan to commence the process of continuous improvement in readiness for the next IiP assessment.

Whatever the option that an organisation decides to implement, Seltics ensure return on investment by supporting the organisation to highlight evidence of improvement in business performance.
